

Washington Vaccine Association Assessment Grid

Updated on 2/27/2015

FOR ALL CLAIMS WITH A DATE OF SERVICE ON OR AFTER DECEMBER 1st, 2013.

Please note that this WVA Assessment Grid, **effective December 1, 2013**, replaces the grid last updated on April 1, 2013. The grid lists vaccines and their corresponding CPT codes that are part of the dosage-based assessment (DBA) process for providers, health insurance carriers, and third party administrators. There are other childhood vaccines (and corresponding CPT codes) that are not included in the DBA process and, therefore, no assessment is needed. The availability of specific vaccine brands will be determined by the manufacturer and all brands of flu vaccine may not be part of the childhood vaccine program.
