



BILLING UPDATE

Dear Childhood Vaccine Program Provider:

Effective **September 12, 2023**, COVID vaccines for commercially insured children (non-VFC) under the age of 19 are no longer be funded by the Federal government. They will be available through the Childhood Vaccine Program's (CVP) Immunization Information System (IIS) ordering platform and added to the [WVA Vaccine Assessment Grid](#) for billing purposes. **See billing code changes in the table below.**

Starting **September 14, 2023**, these vaccines should be billed to payers using the WVA's dosage-based assessment (DBA) process for patients under the age of 19 covered by commercial insurance; use the V25 Eligibility Code during the [WA DOH eligibility screening process](#). **As a provider, you will need to update your billing systems/fee schedules to include these vaccines when submitting DBAs. The WVA Assessment Amount is the same for all COVID vaccines.**
