Please note that there has been an update to the 2025-26 WVA Assessment Grid (the "Grid") regarding COVID-19 vaccines.

Effective for dates of services between July 1, 2025 and June 30, 2026, COVID-19 vaccine NDCs have been updated in the 2025-26 WVA [Vaccine Assessment Grid](#) (the "Grid").

Reminders:

- The current WVA [Vaccine Assessment Grid](#) is in effect between July 1, 2025 through June 30, 2026, and is posted to the WVA's website in both PDF and Excel format.
- The *Grid* lists vaccines and their corresponding CPT codes that are part of the dosage-based assessment (DBA) process for providers, health insurance carriers, and third-party administrators (TPAs). In effect, the *Grid* is the equivalent to a fee schedule. Providers are required to submit the DBA at the *Grid* amount, and **health insurance carriers and TPAs are required to remit the full amount to the WVA.**
